Restricted access does not prohibit disclosure of documents required to be released pursuant to public access laws, subpoena or court order. ## BY SIGNING AND SUBMITTING THIS REQUEST, THE UNDERSIGNED ACKNOWLEDGES THAT:

- > If the covered person's name is changed, or altered on a deed, covered person MUST resubmit this form to retain restricted access.
- > Covered person will notify the Ohio County Assessor immediately upon sale of property or of any change in circumstance that makes the property ineligible for restriction.
- > Certain services related to the covered person's name and property may be inaccessible, including but not limited to, the covered person's ability to view property taxes online, and possible difficulty/delay in title search for refinancing or purchasing/selling a home.
- > Ohio County reserves the right to contact you if we have a reasonable belief that you no longer own the above stated property and/or are no longer eligible to restrict your address.
- > Should the covered person want restricted access removed, they must appear in person at the Assessor's Office and sign the release at the bottom of this original form on file at the Assessor's Office.
